conditions. The role of the nurses can be established under the components of performance, key result areas, expected roles and even the individual experience. Heman et al (2018)



## 3. Research Process:


- This study is based on secondary data and the researcher has used the secondary data for reaching the research gaps, establishing objectives and even looking of the reference of previous studies in the recent past.

## 2. Problem-solving ability:


